Clarifications and changes to the Drawings and Specification

- 1) Bids shall be emailed to both <u>kbemowski@park-ridge.us</u> and <u>henry@ratschengineering.com</u> by 2:00 pm on Monday, April 13, 2020.
- 2) Use the revised bid form.
- 3) Natural stone shall be Golden Sands Custom Blend Full Veneer natural stone, standard 2"-8" heights. Provide a limestone sills. Provide Natural return at the doors and windows.
- 4) Alternate Bid A11 Alternate Bid #11 In lieu of the natural stone, provide County Materials Reflections Stone Full Veneer. Select from full line of manufacturer's colors. Provide standard concrete sills.
- 5) Steel studs may be substituted for the wood studs. Contractor shall verify to engineer the gauge of the steel studs that are being used.
- 6) Provide washing machine wall box and hammer arrestors for the extractor.
- 7) Provide power to vestibule heaters located in Rooms 105, 106, and 107.
- 8) All new motors and equipment in the Fire Station shall be single phase. The only three phase items are the existing well pump and the existing Mako Breathing Module.



- 9) Data Cabinet shall be an enclosed wall mount 8U rack with hinged front door. Provide minimum 16-port patch panel for data and a minimum 8-port patch panel for telephones. Provide network switch. Provide a buried minimum 1" PVC conduit from the existing mechanical by the existing electrical panel to the new mechanical room. Pull a minimum of three CAT 6 lines from the existing mechanical room to the new mechanical room. All data and terminations shall be CAT 6. Data Cabinet to be located in Mechanical Room 108.
- 10) Water heater shall be A.O. Smith G6-PVT5050NV, 50 gallon, natural gas, power-vent through wall.
- 11) Provide new buried gas line from existing gas meter on west wall of existing village hall.
- 12) Wall between Fire Equipment 101 and Training 104 shall have full height liner panel to insulation on the Fire Equipment side of the wall.
- 13) Corian sills shall be from price group A or B.
- 14) Metal building panels shall have a Kynar Coating or equal.
- 15) See page 3 for Electrical One-line diagram.
